

**Union Township Board of Supervisors
Re-Organization Meeting
January 3, 2017**

The Re-organization Meeting of the Union Township Board of Supervisors for the year 2017 was held on January 3, 2017 at 7:00 PM with all supervisors present.

Meeting was called to order by appointed temporary Chairman Tom Reitz. Motion was made by Billy Allred, seconded by Tom Reitz and carried to appoint Nelson Poe as Chairman. Wendy Yoder acted as temporary secretary.

The elected Chairman then presided over the meeting. Motion was made by Billy Allred, seconded by Nelson Poe and carried to appoint Tom Reitz as Vice-Chairman. Motion was made by Nelson Poe, seconded by Billy Allred and carried to appoint Wendy Yoder as Secretary/ Treasurer. Motion made by Nelson Poe, seconded by Billy Allred and carried to appoint Tom Reitz as Assistant Secretary/ Treasurer.

Roadmaster's Salary – Motion made by Billy Allred, seconded by Tom Reitz and carried to have the Roadmaster's salary remain at \$24.50 per hour.

Supervisors Laborer – Motion made by Tom Reitz, seconded by Billy Allred and carried for the supervisor laborer salary to remain at \$15.00 per hour.

Township Laborer – Motion made by Tom Reitz, seconded by Billy Allred and carried for the township laborer salary to remain at \$15.00 per hour.

Equipment Operator/ CDL - Motion made by Billy Allred, seconded by Tom Reitz and carried for the equipment operator salary for Jeff Brouse and Justin Brouse to be set at \$20.00 per hour.

Secretary/ Treasurer – Motion made by Billy Allred, seconded by Tom Reitz and carried for the secretary/ treasurer salary to remain at \$950.00 per month.

Treasurers Bond – Motion made by Billy Allred, seconded by Tom Reitz and carried for the bond to remain at \$300,000.00
