

ORDINANCE NO. 83-2

AN ORDINANCE OF THE TOWNSHIP OF UNION, UNION COUNTY, PENNSYLVANIA, PROVIDING FOR THE VACATION OF THE EASTERN PORTION OF TOWNSHIP ROAD NO. 333, KNOWN AS SANDEL ROAD, FROM THE EASTERN RIGHT-OF-WAY LINE OF U.S. ROUTE 15 TO THE WESTERN RIGHT-OF-WAY LINE OF TOWNSHIP ROAD NO. 364.

WHEREAS, the Board of Supervisors of the Township of Union, Union County, Pennsylvania, deem the vacation of the hereinafter described eastern portion of Township Road No. 333, known as Sandel Road, to be for the public good and benefit of the Township.

NOW, THEREFORE, be it enacted and ordained by the Board of Supervisors of the Township of Union, Union County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same as follows:

Section 1. The eastern portion of Township Road No. 333, known as Sandel Road, from the eastern right-of-way line of U.S. Route 15 to the western right-of-way line of Township Road No. 364 in the Township of Union is hereby vacated as a public road.

Section 2. The eastern portion of Township Road No. 333, known as Sandel Road, hereby vacated as a public road is more particularly bounded and described as follows, to wit:

BEGINNING at a point on the eastern right-of-way line of U.S. Route 15 at the northwestern corner of lands now or formerly of Kenneth J. Hafer, et ux.; thence eastwardly along the said lands of Kenneth J. Hafer, et ux., a distance of two hundred sixty-four (264') feet, more or less, to a point on the western right-of-way line of Township Road No. 364; thence northwardly along the said western right-of-way line of Township Road No. 364, a distance of thirty-three (33') feet to a point at the southeastern corner of lands now or formerly of Anna J. Hafer; thence westwardly along the said lands of Anna J. Hafer, a distance of two hundred sixty-four (264') feet, more or less, to a point on the eastern right-of-way line of U.S. Route 15; thence southwardly along the said eastern right-of-way line of U.S. Route 15, a distance of thirty-three (33') feet to the point of BEGINNING. CONTAINING eight thousand seven hundred twelve (8,712) square feet, more or less.

Section 3. The eastern portion of Township Road No. 333, known as Sandel Road, hereby vacated as a public road is further identified in red on the map of the Township attached hereto and made a part hereof.

Section 4. All ordinances or parts of ordinances inconsistent herewith be and the same are hereby repealed.

Section 5. This Ordinance shall become effective thirty (30) days after enactment.
