

ORDINANCE NO. 93-2

AN ORDINANCE OF THE TOWNSHIP OF UNION, UNION COUNTY, PENNSYLVANIA, AMENDING SECTION 1 OF ORDINANCE NO. 87-2, ENACTED JULY 7, 1987, AS AMENDED BY ORDINANCE NO. 91-1, ENACTED FEBRUARY 5, 1991, BY PROVIDING FOR THE ERECTION AND MAINTENANCE OF ADDITIONAL STOP SIGNS AT THE CORNERS OF CERTAIN DESIGNATED STREET INTERSECTIONS IN THE WOODSEdge, WINFIELD ESTATES AND WYNDHAM CREST SUBDIVISIONS.

Be it enacted and ordained by the Board of Supervisors of the Township of Union, Union County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same as follows:

Section 1. Section 1 of Ordinance No. 87-2, enacted July 7, 1987, as amended by Ordinance No. 91-1, enacted February 5, 1991, is hereby amended by the addition thereto of Subsections 14, 15, 16 and 17 to read in their entirety as follows:

"14. Northwestern intersection of Woodsedge Avenue and Township Route No. T-358, known as Trutt Road, in the Woodsedge Subdivision.

15. Southeastern intersection of Evergreen Drive and Township Route No. T-333, known as Sandel Road, in the Winfield Estates Subdivision.

16. Southeastern intersection of Crestview Drive and Evergreen Drive in the Winfield Estates Subdivision.

17. Northwestern intersection of Gregory Drive and Township Route No. T-362, known as Mull's Hollow Road, in the Wyndham Crest Subdivision."

Section 2. Except as amended by this Ordinance and Ordinance No. 91-1, enacted February 5, 1991, all of the provisions of Ordinance No. 87-2, enacted July 7, 1987, shall remain in full force and effect.

Section 3. All ordinances or parts of ordinances inconsistent herewith be and the same are hereby repealed.

Section 4. This Ordinance shall become effective five (5) days after enactment.
